

Release And Waiver Of Liability And Indemnity

Agreement To Louisiana 4X4 Club Inc.

It is fully understood by each of the undersigned that there is some inherent risk associated with the event, including damage to vehicles and property, personal injury and/or death.

IN ADDITION, the undersigned **AGREES TO INDEMNIFY AND HOLD HARMLESS** the Releasees from any loss, liability damage, or cost they incur due to such participation by the undersigned, whether caused by Releasee's negligence or otherwise and **AGREES TO ASSUME FULL RESPONSIBILITY AND RISK** for any bodily injury, death, or property damage from Releasee's acts, negligence or otherwise while the undersigned is participating in this event organized and/or sponsored by the Louisiana 4X4 Club.

*IN ADDITION the undersigned understands that the Club is temporarily without Liability Insurance that would protect the land owner and **AGREES TO IDEMNIFY AND HOLD HARMLESS** the landowner from any loss, liability damage or cost they incur due to such participation by the undersigned, whether caused by land owners negligence or otherwise and **AGREES TO ASSUME FULL RESPONSIBILITY AND RISK** for any bodily injury, death, or property damage from the landowner's acts, negligence or otherwise while the undersigned is participating in this event organized and/or sponsored by the Louisiana 4X4 Club.*
